Enjoying your Priority

Friends of Wigmore Hall enjoy priority booking for all Wigmore Series concerts and events, ahead of subscribers to the Mailing List and the general public. Bookings are processed in order of membership level, starting with Patrons, followed by Benefactors, then Supporters, then Member Friends.

Paying by Direct Debit

Member Friends and Supporter Friends opting to pay by Direct Debit will benefit from a rate reduction for their first year of membership. Member Friends will pay £35 for the first year (£40 subsequently) and Supporter Friends will pay £85 (£100 subsequently).

Supporters, Benefactors and Patron Friends can elect to spread their annual donation over ten months, by Direct Debit. Please fill in the Direct Debit mandate attached and indicate on the Membership Form if you wish to spread your payment.
